PROGRAM PARTICIPATION GUIDELINES

PROGRAM PARTICIPANTS: PLEASE REVIEW CAREFULLY

This one-page “Program Participation Guidelines” sheet is designed to help ensure that the Conference program runs smoothly and on time ... if you are participating in the program, we request that you take a moment to review these Guidelines prior to your panel or presentation and abide by them.

1. Panel Moderators/Commentators (plenary/concurrent/roundtable):

Moderators/Commentators are key to any well-conducted panel. The moderator's/commentator's role is multifaceted. Please: (1) introduce the panel; (2) introduce the panelists; (3) keep time; (4) comment briefly on the panel presentations after all the presenters are done as a way of transitioning to audience question-and-answer discussion; (5) moderate the question-and-answer discussion period with the audience. If you are a panel moderator/commentator (either plenary or concurrent) please begin by mentioning the overall title of your panel and speak substantively for 5 minutes about the theme(s) of your panel. During these substantive remarks, as well as in the substantive commentary that follows the presentations, moderators/commentators are encouraged to express some of their thoughts as well. To (briefly) introduce each presenter, please ascertain in advance how each presenter would like you to introduce her/him. Finally, please make sure to keep strict time throughout (refer to other portions of these guidelines for time allotments for presenters).

Total allotted time for each panel introduction and post-presentations commentary by the moderator/commentator: 10-15 minutes.

2. Panel Presentations (plenary/concurrent/roundtable):

The panel presentations constitute the bulk of the program, and it therefore is particularly important that panelists cooperate fully in the smooth running of the program and schedule. All panelists should carefully review this schedule and program to confirm the time and place of your event. This schedule and program also explains the theory behind each panel's composition as well as the overall organization of the program so that all presenters may tailor their papers accordingly. Please contact your moderator or other panelists to discuss how each panelist will participate to produce a series of presentations and commentaries that "hang together" well. Even though all moderators are requested to keep time actively and strictly, we plead for your cooperation: ALL presenters should be prepared to observe their time allocations. SYMPOSIUM SUBMISSION GUIDELINES

CONFERENCE ATTENDEES: PLEASE REVIEW CAREFULLY

The Guidelines outlined below are designed to provide all LatCrit IX registrants with the necessary information to submit a timely essay for publication in the symposium that will be published based on this Conference. Although we expect program participants to submit symposium essays, ALL attendees or registrants are invited to do so; *whether or not your name appears in the Conference program, you are invited to participate in the symposium by submitting an essay inspired by the Conference.*

The LatCrit IX symposium will be published by the conference co-sponsor, the *Villanova Law Review*. This publication follows the previous LatCrit symposia, most of which similarly commemorate and memorialize our gatherings.¹ These symposia also help to nudge along the production of critical knowledge on socio-legal issues of special significance to Latinas/os and other outgroups. We expect the published version of LatCrit IX will be as powerful as the live version (or more so). Please plan ahead *NOW* to make sure that you will be able to meet the **August 16, 2004 deadline**, which is ample time given the length and nature of the pieces (see below). *This date is final because we have arranged with the student editors to submit all the symposium contributions to them upon the commencement of the school year.*

Generally, symposium essays are a form of “oral essay” conveying a basic sense of the Conference to those unable to attend. Essays should engage and elaborate upon comments, observations or exchanges occurring during the conference, and may address or extend to any social or legal matters affecting Latina/o or other outsider communities. Due to space limitations, your essay should be between 20-30 pages in length (double-spaced, including footnotes). Footnoting is not at a premium: include footnotes wherever you think they will be useful, but do not feel compelled to footnote extensively. Please format your footnotes according to the latest edition of The Bluebook.

All submissions must be **received** no later than **August 16th** as a Word (MSWord 95 or above) attachment, sent directly to **both** review@law.villanova.edu and lyon@law.villanova.edu. If you cite materials other than traditionally used in U.S. legal scholarship, for example economic or international literature, **it is imperative that you provide us with photocopies of unusual sources**. This advance consideration will help the editors (and us) ensure a smooth and timely publication schedule. We look forward to receiving your timely essay at the end of the summer, and hope that the intervening time is both enjoyable and productive!

*Culture and Kulturkampf in the United States and Beyond: Mapping the Lines of Critical Engagement***

In the United States, politicians, judges and lawmakers have sometimes invoked the concept of cultural warfare to explain events such as the unprecedented judicial intervention in the 2000 Presidential election. Internationally, some have advanced a “clash of civilizations” model when discussing cross-cultural relations. In both the domestic and international settings, so-called culture wars appear, at the very least, to denote a loose yet concerted effort by some groups to impose particular types of customs, beliefs and arrangements upon traditionally subordinated groups. To kick off this year’s Conference program, this moderated roundtable queries whether current affairs in the United States and globally may or should be analyzed through the lens of a “kulturkampf” – a multifaceted yet coordinated campaign in which historically dominant groups associated with traditional neocolonial elites seek to “roll back” or check the civil rights and human rights gains that helped democratize some regions of the world during the Twentieth Century. The discussants will consider the meaning of the term, whether any theoretical insights or practical benefits can be derived from a kulturkampf perspective on recent events, and similar questions. As always, the aim of the opening roundtable discussion is to apply and connect critical theory to current events to contextualize the Conference and theme as a whole.

Justice Pedagogy: Experiential and Service Learning for Critical Theory Teachers

U.S. law schools now regard experiential and service learning as important elements of legal education but these methods remain confined chiefly to two curricular sites: clinics and externships. Various attempts to incorporate service and experiential elements into first-year and other doctrinal and theory classes are ongoing, and some efforts have been made to record and highlight successful models. Similarly, a growing body of clinical education literature discusses the use of critical theory in clinical teaching. Yet, little is available addressing the use of service and experiential learning in non-clinical critical theory teaching. Therefore, a group of clinicians and theorists have begun conversations to explore ways of mixing theory and clinical methodology across the curriculum, and this plenary panel will focus on that question as well. After initial remarks on clinical theory and the current state of service in classroom teaching in U.S. law schools, the discussion will turn to the promise and pitfalls of service-learning in concrete settings, including the realities of shaping a service component in LatCrit's new study-abroad summer program, the Critical Global Classroom (CGC).

As the "war on terrorism" stretches into its third year, culturally loaded images increasingly are deployed to justify the latest acts of the ruling elites. BARNES FOUNDATION MUSEUM VISIT

The LatCrit IX conference ends on Saturday night, May 1ST. On Sunday, May 2, most attendees will be making their way either to the nearby site of the Annual Planning Retreat (to be held at a hotel in Philadelphia) or to the airport/train station in southwest Philadelphia on their way back home. However, the LatCrit IX Planning Committee is working to arrange for a group of interested folks to get to their Sunday destination with a two hour stopover at the Barnes Foundation Museum in Merion, Pennsylvania. The plan is to leave the conference hotel, the Desmond, at 10:30 a.m., enter the museum collection at 11:30 p.m., and leave the museum by 2:00 p.m. This schedule will enable Planning Retreat participants to make the 6 p.m. Retreat kick-off, as well as allow other folks to make their mid-afternoon trains and late-afternoon flights back home. The Barnes Foundation houses one of the finest collections of French early Modern and Post-impressionist paintings in the world. An extraordinary number of masterpieces by Renoir, Cezanne and Matisse provide a depth of work by these artists unavailable elsewhere. The collection includes works by Picasso, Seyrat, Rousseau, Modigliani, Soutine, Monet, Manet, Degas and others. Art from around the globe is grouped with fine examples of African sculpture and textiles. Some of the most important works of European art in the last 100 years hang in The Barnes Foundation's gallery, including Matisse's *Joy of Life* and *The Dance*, Cézanne's *Nudes in Landscape* and *Card Players & Girl*, Renoir's *After the Concert* and *The Artist's Family* and Seurat's *Models*. Reservations must be made well in advance to view the collection, so the LatCrit conference organizers wish to create a process to allow attendees to view this world-renowned collection. For more information, see www.barnesfoundation.org.

The collection alone is well worth the visit, but we particularly wanted to make this opportunity available to LatCrit IX attendees because of the collection's interesting history. Henry Barnes, born in a working-class neighborhood in the 1870s, built his fortune by inventing and manufacturing an antiseptic product named Argyrol. He personally purchased and placed the paintings and artwork in his collection, a fairly typical industrial-baron-turned-patron-of-the-arts narrative, and we are not aware of any investigation into the collection methods regarding the African art, but assume that followed the typical colonial pattern as well. However, what is

interesting is that Mr. Barnes nurtured a life-long preoccupation with social justice and African-American rights, and in a controversial move left his art collection under the control of Lincoln University, one of the region's pre-eminent historically black colleges. A legal battle for control over the collection is currently underway, and will be discussed by a Lincoln University board member on the local issues panel.

Because of the museum's legal and resultant funding difficulties, there is a chance that the collection will not be available for viewing on May 2. Therefore, if you are interested in this "departure side trip," please don't send any money. Just let us know by March 30 whether you would be willing to attend the trip if it were made available by providing the following requested information and faxing it to us along with your registration form by March 30. We will follow up by email to let you know if the trip is going forward and to make further arrangements with you. If you have any questions, please email Beth Lyon at lyon@law.villanova.edu.

There is no café at the museum, so we will probably arrange to pick up sandwiches and eat them in the vans or on the extensive Barnes grounds, weather permitting. There are no group tours provided, but there is a free docent tour at 1 p.m. that individuals can sign up for upon entering the collection. Family members are welcome to sign up as well. As with most museums, children are permitted in the collection, but must be watched carefully. Strollers are permitted but not backpacks.
